What is the purpose of this update?

This document tells you how the Nikko AM Global Equity Unhedged Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to outperform the MSCI All Countries World Index (net dividends reinvested), in New Zealand Dollars (unhedged) by 3.0% p.a. over a rolling three year period before fees, expenses and taxes. The Fund provides investors with long term growth from an actively managed investment portfolio selected from global equity markets. No foreign currency hedging is undertaken in this fund.

What are the risks of investing?

Risk indicator for Nikko AM Global Equity Unhedged Fund:

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term. For the purpose of this example, the start of the year is 1 April 2016.

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$948 (that is 9.48% of her initial \$10,000). Hayley paid no other charges. This gives Hayley a total return after tax of \$840 for the year.
