What is the purpose of this update?

This document tells you how the Nikko AM NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to outperform the Bloomberg NZ Bond Bank Bill Index by 0.20% p.a. over a rolling three year period before fees, expenses and taxes. The Fund provides investors with regular income by constructing an actively managed investment portfolio of short term deposits and bonds whilst preserving capital value.

What are the risks of investing?



Risk indicator for Nikko AM NZ Cash Fund

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

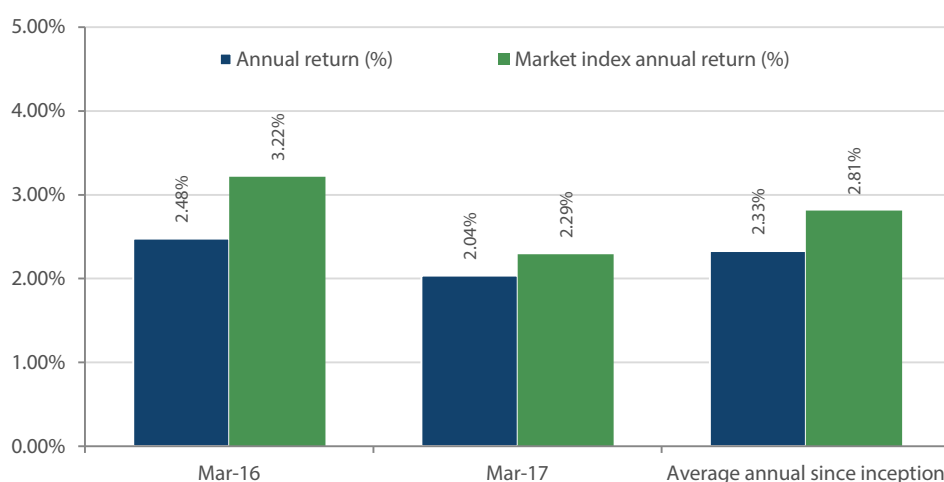
How has the fund performed?

What fees are investors charged?

Investors in the Nikko AM NZ Cash Fund are charged fund charges. In the year to 31 March 2017, these were:

Example of how this applies to an investor

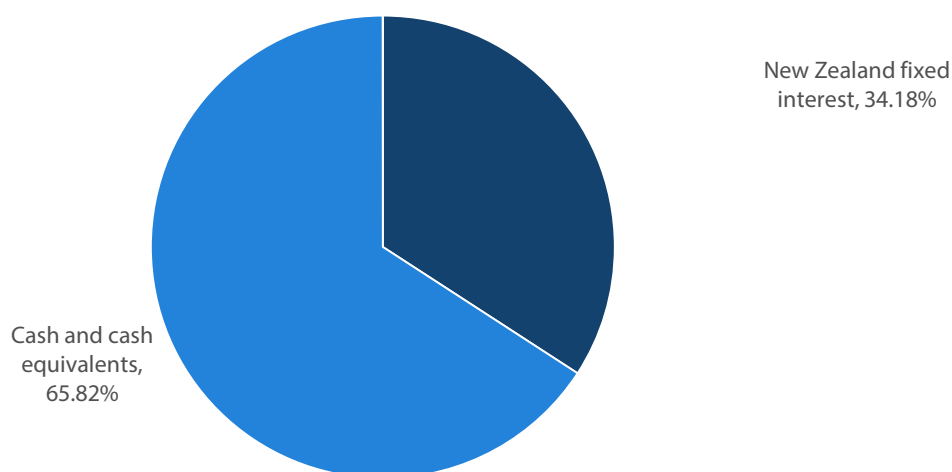
Small differences in fees and charges can have a big impact on your investment over the long term. For the purpose of this example, the start of the year is 1 April 2016.

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$284 (that is 2.84% of her initial \$10,000). Hayley paid no other charges. This gives Hayley a total return after tax of \$204 for the year.

Notes

¹ Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (from 1 January 2013 to 12 June 2014) from the S&P/NZX Bank Bills 90-Day Index, which was the applicable index at the time. As a result of this, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.

² The bar chart shows fund returns after the deduction of fees and taxes, however, the market index returns are shown before any fees or taxes are deducted.
