


Image: Abstract aerial view of river bed, Canterbury Plains, Christchurch, NZ.

Changes relating to the scheme

On 15 March 2019 the Nikko AM Multi-Strategy Fund was wound up.

On 19 February 2019 the SIPO was updated, replacing the version dated 31 May 2018. This update was made to:

- Reflect the wind up of the Nikko AM Multi-Strategy Fund,
- Remove reference to Global Equities Hedged and Unhedged Fund for the Nikko AM Growth, Balanced and Conservative Funds
- The change of benchmarks and objectives for both the Nikko AM NZ Corporate Bond Fund and the Nikko AM NZ Bond Fund
- Additional specific investment restrictions for the Nikko AM Global Shares Fund
- Additional specific investment restrictions for the Nikko AM Global Bond Fund

On 31 May 2018, the SIPO was updated, replacing the version dated 3 April 2018. This update was made to reflect the changes to the strategic asset allocations (SAAs) for the Nikko AM Growth, Balanced and Conservative Funds.

On 3 April 2018, the SIPO was updated to reflect the launch of the Nikko AM Option Fund, the Nikko AM Conservative Fund, Nikko AM Balanced Fund, Nikko AM Growth Fund.
