Fund Update



What is the purpose of this update?

This is a replacement fund update, replacing the previous fund update for the quarter ending 31 December 2016, first made publically available on 13 February 2017. We identified that in that fund update, the calculation of the annual return (after deductions for charges and tax) was incorrect. This has now been corrected in this fund update and has resulted in changes to the following sections: "How has this fund performed?" and "Example of how this applies to an investor".

This document tells you how the Nikko AM Concentrated Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to outperform the RBNZ Official Cash Rate plus 5.0% per annum over a rolling three year period before fees, expenses and taxes. The Fund aims to provide investors with a concentrated exposure to New Zealand and Australian equity markets from an actively managed investment portfolio.

What are the risks of investing? Risk indicator for Nikko AM Concentrated Equity Fund




Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Hayley had \$10,000 in the fund at the start of the year² and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$1,794 (that is 17.94% of her initial \$10,000). Hayley paid no other charges. This gives Hayley a total return after tax of \$1,638 for the year.
