Fund Update



What is the purpose of this update?

Please note that previous fund updates for the quarters ending 30 September 2016, 31 December 2016 and 31 March 2017 were reissued on 22 May 2017. We identified that in those fund updates, the calculation of the annual return (after deductions for charges and tax) was incorrect. This was corrected and resulted in changes to the following sections: "How has this fund performed?" and "Example of how this applies to an investor" of those fund updates.

This document tells you how the Nikko AM Core Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to outperform the S&P/NZX 50 Index Gross (with Imputation Credits) by 3.00% p.a. over a rolling three year period before fees, expenses and taxes. The Fund provides investors with an exposure to New Zealand and Australian equity markets from an actively managed investment portfolio with potential for growth of income and capital.

What are the risks of investing? Risk indicator for Nikko AM Core Equity Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Annual return graph¹



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to June 2017.

Important: This does not tell you how the fund will perform in the future.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

Prior to 1 October 2010 the returns in this update are after tax at 30%. From 1 October 2010 onwards the returns are after tax at 28%.

What fees are investors charged?

Investors in the Nikko AM Core Equity Fund are charged fund charges. In the year to 31 March 2017, these were:

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term. For the purpose of this example, the start of the year is 1 April 2016.

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$838 (that is 8.38% of her initial \$10,000). Hayley paid no other charges. This gives Hayley a total return after tax of \$733 for the year.
