Fund Update



What is the purpose of this update?

This document tells you how the Nikko AM NZ Corporate Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to outperform the Bloomberg NZBond Government 0+ Year Index by 1.50% p.a. over a rolling three year period before fees, expenses and taxes. The Fund provides investors with regular income by constructing an actively managed investment portfolio of New Zealand bonds, deposits and cash while protecting the capital value of investors' funds.

What are the risks of investing?

Risk indicator for Nikko AM NZ Corporate Bond Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

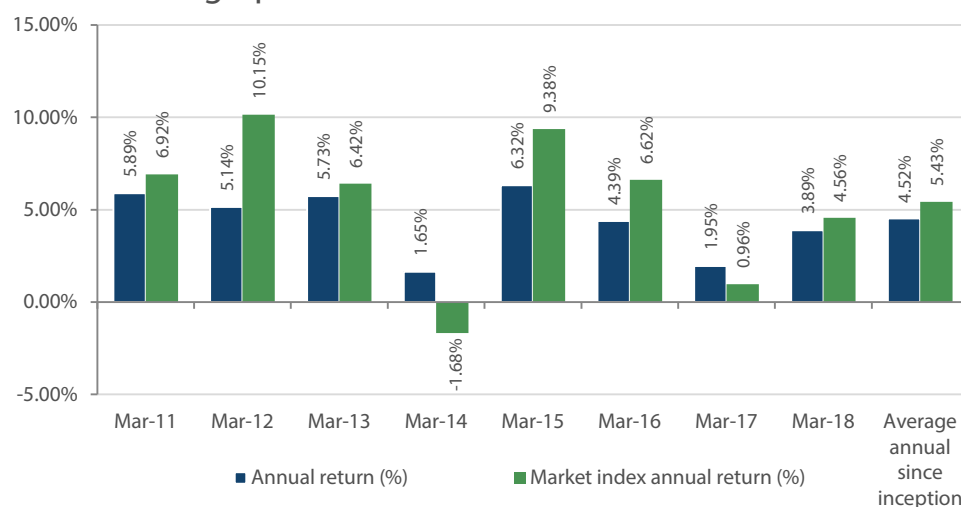
How has the fund performed?

Example of how this applies to an investor

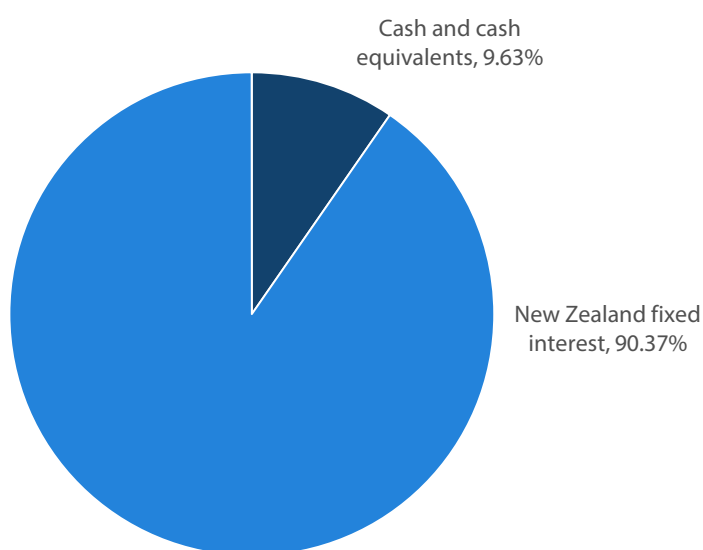
Small differences in fees and charges can have a big impact on your investment over the long term. For the purpose of this example, the start of the year is 1 April 2017.

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$543 (that is 5.43% of her initial \$10,000). Hayley paid no other charges. This gives Hayley a total return after tax of \$389 for the year.
