

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term. For the purpose of this example, the start of the year is 1 April 2018.

Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$242 (that is 2.42% of his initial \$10,000). Simon paid no other charges. This gives Simon a total return after tax of \$176 for the year.
