What is the purpose of this update?

This document tells you how the Nikko AM Concentrated Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The fund aims to outperform the RBNZ Official Cash Rate plus 5.0% per annum over a rolling three year period before fees, expenses and taxes. This fund aims to provide investors with concentrated exposure to New Zealand and Australian equity markets from an actively managed investment portfolio.

What are the risks of investing?

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$733 (that is 7.33% of his initial \$10,000). Simon paid no other charges. This gives Simon a total return after tax of \$691 for the year.²
