Fund Update



What is the purpose of this update?

This document tells you how the Nikko AM Concentrated Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to outperform the RBNZ Official Cash Rate plus 5.0% per annum over a rolling three year period before fees, expenses and taxes. This fund aims to provide investors with concentrated exposure to New Zealand and Australian equity markets from an actively managed investment portfolio.

What are the risks of investing?

Risk indicator for Nikko AM Concentrated Equity Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 December 2020.

Important: This does not tell you how the fund will perform in the future.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

From 1 April 2008 to 30 September 2010 the returns are after tax at 30% and from 1 October 2010 onwards the returns are after tax at 28%.



What fees are investors charged?

Investors in the Nikko AM Concentrated Equity Fund are charged fund charges. In the year to 31 March 2020, these were (inclusive of GST where applicable):

^{*} It is expected that in the current fund year ending 31 March 2021 that expenses of the fund will increase. For the 12 months ended 31 December 2020, total fund charges are 1.97%. The increase is due to higher performance returns, resulting in a higher performance fee.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$1731 (that is 17.31% of his initial \$10,000). Simon paid no other charges. This gives Simon a total return after tax of \$1717 for the year.²
