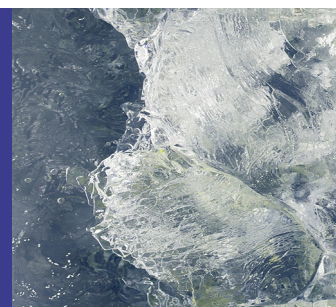

What is the purpose of this update?

This document tells you how the Nikko AM Global Shares Hedged Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

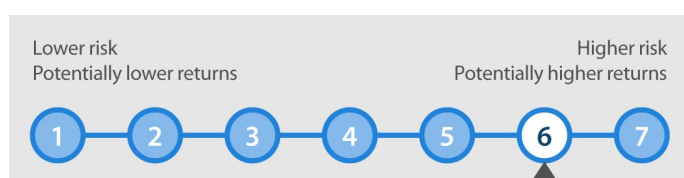
Description of this fund

The Fund aims to outperform the MSCI All Countries World Index, with net dividends reinvested, gross hedged 139% to NZD by 3.0% p.a. over a rolling three year period before fees, expenses and taxes. The Fund seeks to provide investors with a relatively concentrated actively managed investment portfolio of global equities to achieve long term capital growth.

What are the risks of investing?

Risk indicator for Nikko AM Global Shares Hedged Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

What fees are investors charged?

Investors in the Nikko AM Global Shares Hedged Fund are charged fund charges. Based on the PDS, dated 10 August 2020, these were expected to be (inclusive of GST where applicable):

Example of how this applies to an investor

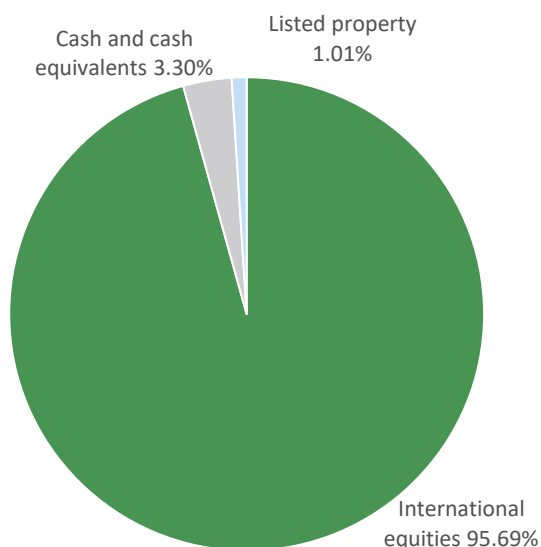
Small differences in fees and charges can have a big impact on your investment over the long term.

Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$2319 (that is 23.19% of his initial \$10,000). Simon paid no other charges. This gives Simon a total return after tax of \$2149 for the year.²

The total value of the top 10 investments makes up 33.56% of the net asset value of the fund.

Currency hedging is material to the fund. As at 31 December 2020, the value of all hedges totalled 7.61% of the fund's net asset value.

Any foreign currency exposure is gross hedged at 139% to NZD. The permitted operational hedging range is 134% to 144%.

Notes

¹ Because the fund is less than five years old, the risk indicator uses returns data from for the period January 2016 to April 2019 from the MSCI World Index (net dividends reinvested). As a result of this, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.

² For the purposes of this example, the start of the year is 1 January 2020.

³ All investments described in this fund updates are in New Zealand dollars.
