

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

At the end of the year, Simon received a return after fund charges were deducted of \$133 (that is 1.33% of his initial \$10,000). Simon paid no other charges. This gives Simon a total return after tax of \$94 for the year.²
