What is the purpose of this update?

This document tells you how the Nikko AM ARK Disruptive Innovation Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to outperform the benchmark of an absolute return of 10% per annum over a rolling five-year period before fees, expenses and taxes. The fund provides access to a global share portfolio that offers thematic exposure to disruptive innovation across a number of sectors, and geographies.

What are the risks of investing?

Risk indicator for Nikko AM ARK Disruptive Innovation Fund:



Small differences in fees and charges can have a big impact on your investment over the long term.


Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon incurred a loss after fund charges were deducted of -\$2,096 (that is - 20.96% of his initial \$10,000). Simon also paid no other charges. This gives Simon a total loss after tax of -\$2,177 for the year.³

Notes

¹ Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (for the period January 2017 to August 2019) from the NASDAQ-100 (in NZD). As a result of this, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.

² The bar chart show fund returns after the deduction of fees and taxes, however, the market index returns are shown before any fees or taxes are deducted.
