# NIKKO AM GLOBAL EQUITY MULTI-MANAGER HEDGED FUND

**Fund Update** 



#### What is the purpose of this update?

This document tells you how the Nikko AM Global Equity Multi-Manager Hedged Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The fund aims to outperform the MSCI All Countries World Index (net dividends reinvested), hedged 100% to the New Zealand Dollar by 3.0% p.a. over a rolling three year period before fees, expenses and taxes. This fund aims to provide investors with long term growth from an actively managed investment portfolio selected from global equity markets with currency exposure created as a consequence of global equity investment hedged 100% to the New Zealand Dollar.

## What are the risks of investing?

#### Risk indicator for Nikko AM Global Equity Multi-Manager Hedged Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


## How has the fund performed?

## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$2,375 (that is 23.75% of his initial \$10,000). Simon also paid no other charges. This gives Simon a total return after tax of \$2,107 for the year.<sup>2</sup>

The total value of the top 10 investments makes up 36.22% of the net asset value of the fund.

Currency hedging is material to the fund. As at 30 September 2023, the value of all hedges totalled 0.99% of the fund's net asset value.

Any foreign currency exposure is gross hedged at 100% to NZD. The permitted operational hedging range is 95% to 105%.

The Nikko AM Wholesale Global Equity Hedged Fund, which this fund invests in, enters into foreign currency exchange contracts to mitigate currency risk. It is not possible to fully mitigate all currency risks, and therefore the currency hedging in place may not fully replicate the currency exposure of your investments. In addition, changes in the value of currency hedges will result in exposure to global equities being less than or greater than the value of fund.
