What is the purpose of this update?

Description of this fund

The Fund aims to outperform the Bloomberg NZBond Credit 0+ Year Index by 0.70% p.a. over a rolling three year period before fees, expenses and taxes. The fund aims to provide investors with regular income by constructing an actively managed investment portfolio of New Zealand bonds, deposits and cash whilst preserving the capital value.



Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$602 (that is 6.02% of his initial \$10,000). Simon also paid no other charges. This gives Simon a total return after tax of \$429 for the year.²




