What is the purpose of this update?

Description of this fund

The Fund aims to outperform the MSCI All Countries World Index, with net dividends reinvested, expressed in NZD (unhedged) by 3.0% p.a. over a rolling three year period before fees, expenses and taxes. The Global Shares Fund seeks to provide investors with a relatively concentrated actively managed portfolio of global equities to achieve long term capital growth.


Hayley made the first investment of \$10,000 into the fund and did not make any further contributions. There were no management fees charged during this period. As at 31 December 2018, Hayley incurred a loss after fund charges were deducted of \$167 (that is -1.67% of her initial \$10,000). Hayley also paid \$22.50 in other charges. This gives Hayley a total loss after tax of \$266.50 for the period ending 31 December 2018.
