

What is the purpose of this update?

This document tells you how the Core Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to outperform the S&P/NZX 50 Index Gross with Imputation Credits by 3.00% p.a. over a rolling three year period before fees, expenses and taxes. An actively managed portfolio with potential for growth of income and capital by investing directly into equity market securities listed or contemplated to be listed on any New Zealand or Australian recognised securities exchange.

What are the risks of investing?

Risk indicator for the Core Equity Fund:



Small differences in fees and charges can have a big impact on your investment over the long term.


Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$2780 (that is 27.8% of his initial \$10,000). Simon also paid \$30 in other charges. This gives Simon a total return after tax of \$2615 for the year.⁴

¹ Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (for the period January 2015 to March 2018) from the S&P/NZX 50 Index Gross with Imputation credits. As a result of this, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
