What is the purpose of this update?

This document tells you how the Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The fund aims to outperform the MSCI All Countries World Index, with net dividends reinvested, expressed in NZD (unhedged) by 3.0% p.a. over a rolling three year period before fees, expenses and taxes. The Global Shares Fund seeks to provide investors with a relatively concentrated actively managed portfolio of global equities to achieve long term capital growth.

What are the risks of investing?

Small differences in fees and charges can have a big impact on your investment over the long term.


Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$1172 (that is 11.72% of his initial \$10,000). Simon paid \$30 in other charges. This gives Simon a total return after tax of \$1022 for the year.⁴
