

What is the purpose of this update?

This document tells you how the NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to outperform the Bloomberg NZBond Bank Bill Index by 0.20% p.a. over a rolling three year period before fees, expenses and taxes. The NZ Cash Fund provides investors with a portfolio of short term deposits and bonds while preserving capital value.

What are the risks of investing?

Risk indicator for the NZ Cash Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$183 (that is 1.83% of his initial \$10,000). Simon also paid \$30 in other charges. This gives Simon a total return after tax of \$104 for the year.⁴

¹ Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (from July 2015 to March 2018) from the Bloomberg NZBond Bank Bill index.
