

## Fund Update



## What is the purpose of this update?

This document tells you how the NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Nikko AM NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.


## Description of this fund

The fund aims to outperform the Bloomberg NZBond Bank Bill Index by 0.20% p.a. over a rolling three year period before fees, expenses and taxes. The NZ Cash Fund provides investors with a portfolio of short term deposits and bonds while preserving capital value.

## What are the risks of investing?

### Risk indicator for the NZ Cash Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


## How has the fund performed?<sup>2</sup>

## Annual return graph<sup>2,3</sup>



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to September 2020.

## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$145 (that is 1.45% of his initial \$10,000). Simon also paid \$30 in other charges. This gives Simon a total return after tax of \$76 for the year.<sup>4</sup>

## Notes

<sup>1</sup> Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (from October 2015 to March 2018) from the Bloomberg NZBond Bank Bill index. As a result of this, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.

<sup>2</sup> Performance has been calculated from 23 April 2018, when the first investment was made in the fund.

<sup>3</sup> The bar chart shows fund returns after the deduction of fees and taxes, however, the market index returns are shown before any fees or taxes are deducted.

<sup>4</sup> For the purpose of this example, the start of the year is 1 October 2019.
