# Changes relating to the scheme

On 2 September 2024 a replacement PDS was issued for the Nikko AM Diversified Funds – this was updated to reflect updated Target Asset Allocations for the Wholesale Nikko AM Growth, Balanced and Conservative Funds which the Nikko AM Diversified Funds invest in.

On 2 September 2024 an updated SIPO and OMI were issued to reflect the changes described above.

On 25 March 2025 the Income Fund was closed.

On 1 September 2025 Nikko Asset Management New Zealand Limited will change it's name to Amova Asset Management New Zealand Limited.

The Scheme and fund names will also change to reflect this.
